Margaret Griffin gave the Treasurer's report; the balance on hand as of 6-30-10 was \$8,664.18; deposits in July were \$2,267.22, including interest of \$.13. Disbursements for July totaled \$5,225.64, leaving a balance of \$5,705.76 as of 7-31-10. We have \$100 petty cash on hand. This report, along with bills/receipts, will be filed for year-end audit.

Warren Grant covered upcoming events, asking everyone to support the Dancing With The Stars on Aug. 14. The Shooter Party will be Sept. 19, PIPF is Oct. 16 and Dec. 11 is the RSC Christmas Party. Hospice planning will start after the PIPF event. Warren asked for everyone to volunteer in some capacity for the events. Stacy reiterated excitement for the remainder of the year's events.

Lee Smith reported 288 members and asked for non-members to join. Debra Baker reported on DWTS, saying only two tables were left to purchase. She asked for additional help still needed, particularly working the door.

Jackie Inscore covered details of the PIPF event on Oct. 16. He asked each member to buy a raffle ticket and also if every member sold just one ticket, then all tickets would be sold. There will be a planning meeting on Aug. 17 at 7:00 at TJ's Night Life and anyone who is interested is working the event should attend. Also, Jackie mentioned the "Hike for Hope" on Sept. 18 at Bond Park, which will be a big fundraiser sponsored by PIPF; he asked for anyone to come out to support the event. Also the Shooter Party will be Sept 19, 5:30-7:30 at the Tiki Bar, with Jimmy Pearce providing the music. He

mentioned possibly taking a bus trip in November to another shag club party, asking for feedback on those who might be interested.

Jim Adcox blessed the food; Stacy asked that the meeting be adjourned. Jackie Inscore made a motion to adjourn; it was seconded and moved to do so.
